# MINUTES OF A MEETING OF THE COUNCIL HELD AT 7:30 pm ON TUESDAY 3 NOVEMBER 2015 AT PYE GREEN COMMUNITY CENTRE, HEDNESFORD

Prior to the formal commencement of the meeting the Chairman welcomed Chief Inspector G Knight who gave details of the new policing arrangements that were being piloted in the Cannock Chase area.

He also provided details of crime statistics and indicated the measures that were intended to be put in place to keep the Council informed of police activity. He answered several questions and emphasized the need for members of the public to report any incidents as this would ensure that police resources were directed towards the areas of need. He also encouraged local traders to adopt the "shop watch" scheme which had proved successful in other local towns

As part of the public questions session reference was made to pollution being experienced by residents of properties to the east of Pye Green Road as a result of the residential development of land opposite

With regard to deposits on the road it was noted that problems should be reported to the Highways Authority but that it was the responsibility of the developer to clear any debris

"The Strategic Transport Plan issued by the West Midlands Integrated Transport Authority calls on efforts to be made to increase the use of the M6 Toll from Laney Green to Coleshill. In order to achieve this ambition the Association calls on the Government to abolish the charging regime for the M6 Toll; making it available free of charge to all users. This will have the effect of easing traffic congestion on the entire length of the M6 through Staffordshire and the West Midlands and will take pressure off key trunk roads such as the A5 and A34. It will also have the effect of reducing the financial burden on hauliers and keeping transport costs down for them and members of the general public"

#### d) Rugeley Road Car Park

That representations be made regarding the problems of HGV's and other deliveries to premises serviced by the car park
