NALC advise that the Department for Communities and Local Government has confirmed that the appropriate sum for parish councils for the purposes of section 137(4)(a) of the Local Government Act 1972 for 2015-2016 was **£7.20** per elector (approx. £94,442) and is likely to remain at a similar amount for 2016-17
