2. Declaration of Interest

3. Planning for Christmas Light Switch On Event

Following full council meeting on 3rd September, the termination of the service level agreement by Hednesford in Partnership to deliver the Hednesford Christmas light switch on event, and subsequent resolution for Spotty Dog to coordinate an alternative event, the Regeneration and Community Committee are requested to

convene an extraordinary meeting to agree and advise Spotty Dog on plans going forward. To include actions to manage expectations for the 2024 event

Funds available for event delivery - £3,500

Christmas Tree and lighting infrastructure is accounted for from a separate budget

A discussion took place about managing the public expectations but yet still wanting to ensure the event was worthwhile and essential requirements for the event were shared

It was stated that all Clirs should endeavour to attend and support the event where possible and that a joint statement with HTC and HIP needs to be issued once draft proposal for the event is known from Spotty Dog

Committee felt that the grant funding should be given to Spotty Dog and that Spotty Dog will manage the budget and provide as much as possible with the amount available

A further discussion took place about potentially no longer needing to close the entirety of Market Street

Committee requested:

- Fairground ride for young children
- Father Christmas to be present provide a small gift of sweets to each child
- Wish for schools to be involved suggestion is for Community Officer to work with Spotty Dog and the 5 local primary schools and for each primary school to nominate a pupil who has gone above and beyond or showed determination or personal success through the year and for these 5 to turn on the lights
- Stage and PA
- Music or Christmas activities throughout the day and evening
- Any publicity for the Light Switch on to be joint between HTC and Spotty Dog

Committee informed that Hednesford Town Council:

- Provide a small prize for each child turning on the lights
- Oversee the best dressed window competition for local businesses
- Arrange and cover cost of any road closure change be that times or area
- Provide funding for sweets if current grant does not permit this
- Provide Officer support to liaise with primary schools or any other element of the Light Switch on

Cllr A Pearson informed that a relative who runs a radio station has offered the use of a PA system and stage area free of charge for the event previously and that Cllr A Pearson will follow this up again
